

Largo Attorney Authors Award-Winning Book On Veterans Benefits

LARGO, FL -- The Independent Book Publishers Association has announced that the book, "Veterans Benefits for the Florida Resident," by Largo attorney and veterans advocate John R. Frazier, is a Silver Award winner in the Professional & Technical category of the 2017 IBPA Benjamin Franklin Awards. The distinguished indie book award program recognizes excellence in books published during 2017.

"Veterans Benefits for the Florida Resident" is a self-help resource for veterans and their families. More than 1.6 million U.S. veterans of all ages live in Florida, which is the third largest population of veterans in the U.S. Many of these veterans, their surviving spouses or dependents may be eligible for disability compensation, pension and other more obscure or "hidden" benefits and services provided by the U.S. Department of Veterans Affairs (the VA) and the State of Florida.

"Most veterans are aware of the basic health care, housing, and education benefits the VA offers," said Frazier. "Still, countless veterans and their families do not know about some lesser-known yet extremely important programs. Many financial benefits are also available that can better the lives of disabled or elderly veterans and their loved ones while reducing otherwise crippling costs. One example is the Aid and Attendance benefit, where hardly any people know they're entitled to it. "Our wounded, aging and disabled veterans need efficient access to the benefits they deserve," said Frazier. "I present 'Veterans Benefits for the Florida Resident' to help ensure Florida veterans get a fair deal."

Frazier is a VA-accredited attorney and a member of the National Organization of Veterans Advocates Inc., the National Academy of Elder Law Attorneys, the Academy of Florida Elder Law Attorneys and the Florida Bar Elder Law Section. He can be reached through his website estatelegalplanning.com.



The Tuskegee Airmen "Top Guns"

The Tuskegee Airmen, Inc. National Convention took place in Orlando in August. Bay County Democratic Veterans Caucus President Sparks was in attendance. The convention highlighted the 70 year anniversary of the first Aerial Gunnery Meet sponsored by the US Air Force in 1949. During this highly segregated time in the US, the 332nd Fighter Group, the Tuskegee Airmen were allowed to participate. Jet technology was being introduced therefore two fighter divisions of the meet were arranged, the jet division and the propeller division. The 332nd Fighter Group was flying the outdated P47 in the propeller division and competed against more advanced aircraft but the Tuskegee Airmen won their division. Official Air Force records listed the winner of the 1949 Aerial Gunnery Meet propeller division as unknown until the mid to late 1990's. The official records and score cards were found and the Tuskegee Airmen were given credit for winning the meet. Two pilots from the 332nd Fighter Group Team, Lt Col Harry Stewart and Lt Col James Harvey told the audience of their experience participating and winning the meet. They spoke of the frustration of not being acknowledged for so many years. The movie "Top Gun" with Tom Cruise popularized the title "Top Gun." The Tuskegee Airmen pilots were considered the "Top Guns" for their meet. The leader of the team, Lt Col Alva Temple who is now deceased, came in second in the individual meet. This presentation was truly a significant event for all that attended and a glimpse into American History as told by those who lived it.
